# **Privacy Policy**

#### Introduction

NetConnect takes your privacy seriously. This Privacy policy ("Privacy policy") explains our data protection policy and describes the types of information we may process when you use one or more of our mobile applications (the "App", "our App") and explains how we and some of the companies we cooperate processing that information.

#### What we collect?

## Sale of data

We do not sell any of your personal data to third parties.

#### **Functional Information**

We ask for and process the following personal information when you use the App. To provide you the service we need these information. Without such information it is impossible to provide complete functionality of the App and perform the requested services.

- Activity Information directly related to your use of the App. After you set the relevant settings on your device we may have technical access to your contact list - in order to be able to match contact details; and to camera roll. However, we cannot collect, store or use the data contained in your camera roll.
- All images & videos that might be processed are stored locally on your device , they are inaccessible to us.
- Deleting Duplicate/Similar Items This app has the efficiency of 95% in aspect of finding duplicate / similar items. Duplicate or similar photos will be deleted from your Gallery while you authorise the app to do so. You are advised to review the selected item before deleting. Note that these delete items will be temporary moved to "Recently Deleted" album in your Photos app. If needed, you can recover those items from there.

## What we do with the information we gather?

We require this information to understand your needs and provide you with a better service, and in particular for the following reasons:

- Information to improve our products and services
- We may periodically send promotional emails about new products, special offers or other information which we think you may find interesting using the email address which you have provided

#### How we use cookies?

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences. We use traffic log cookies to identify which pages are being used. This helps us analyse data about webpage traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system. Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us. You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the website.

#### Links to other websites

Our app may contain links to other content of interest. However, once you have used these links to leave our app, you should note that we do not have any control over that other content. Therefore, we cannot be responsible for the protection and privacy of any information which you provide whilst visiting such sites and such sites are not governed by this privacy statement. You should exercise caution and look at the privacy statement applicable to the website in question.

## **Controlling your personal information**

You may choose to restrict the collection or use of your personal information by not accepting access to your details in the Auth Dialog box. You can also withdraw permissions by the app to access your data by going to the settings.

We will not sell, distribute or lease your personal information to third parties unless we have your permission or are required by law to do so. We will not use your personal information to send you any promotional information. You may request details of personal information which we hold only about legal obligations about you under the Data Protection Act 1998. A small fee will be payable. If you would like a copy of the information held on you please contact us. If you believe that any

information we are holding on you is incorrect or incomplete, please contact us as soon as possible. We will promptly correct any information found to be incorrect.

## **How Long We User Your Data**

We are not saving or sharing any of your personal information unless there is a need of legal actions. However, some data may still be stored for a certain time period (but no longer than the storage purpose requires) if information is necessary to comply with legal obligation

(taxation, accounting, audit) or in order to maintain safety and data backup settings, prevent fraud or other malicious acts.

## Security

The security of your personal information is highly important to us. We follow generally accepted industry standards to protect the personal information submitted to us, both during transmission and once we receive it.

We take reasonable and appropriate measures to protect personal information from loss, misuse and unauthorized access, disclosure, alteration and destruction, taking into account the risks involved in the processing and the nature of the personal information.

We implement appropriate technical and organizational measures, which are designed to implement data-protection principles, such as data minimization, in an effective manner and to integrate the necessary safeguards into the processing. We seek your personal data to be encrypted with proper and strong encryption algorithms, including hashing where possible.

Unfortunately, no method of transmission over the Internet, or method of electronic storage, is 100% secure. But in our case as we do not hold any of your personal information, it seems to be the safest way for your data.
